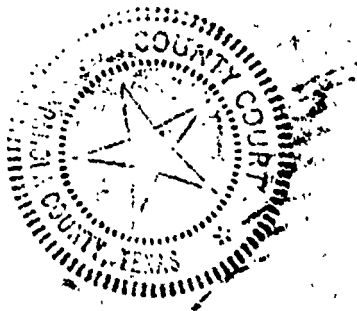

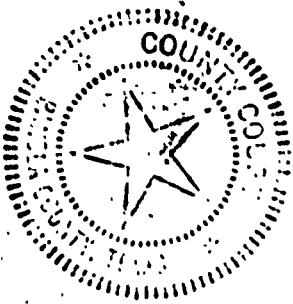

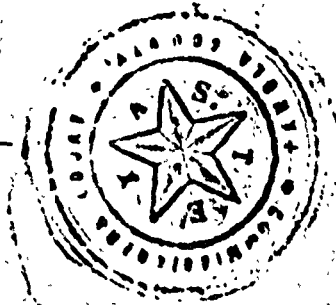
The meeting was then adjourned.





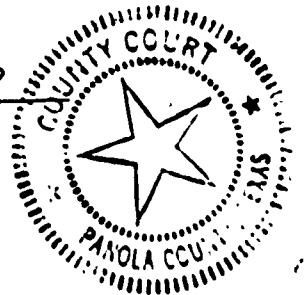
