Termination is the Customer's intent to pay the consideration herein set forth for the full Term or Use. However, in order to not create a debt and be in compliance with the Texas constitution, Panola County reserves the right to terminate this Agreement at the end of the budget years.

**Payment:** County will be invoiced after signing the Agreement and on the anniversary date of the signing of this agreement. Payment is due within thirty (30) days of invoice. Invoice will list the number of seats, annual license fees and hardware charges, if applicable. If county pays in full, invoice will include all hardware, seats, and annual license fees. If county pays annually, first invoice will include all hardware, EA Pollbook Manager, EA Pollbook seats, and first year Annual License Fee.
