



**INSTRUCTIONS TO ALL INTEREST OWNERS**  
Read Carefully Before Signing This Division Order

A **DIVISION ORDER** is a document that enables communication between the payor and the owner, setting out the name and interest, the name of the well and a brief description. It does not alter the terms of any leases.

Two (2) copies of the Division Order are provided. This instrument shows the interest we credited to you and if you claim the interest, please execute one counterpart in accordance with the applicable instructions below.

If you alter this division order for any reason other than to correct your address, please submit documentary evidence to support the change. Other than a name change, the document(s) should be recorded in the parish / county in which the well is located.

**INDIVIDUAL:** Sign your name as shown on the instrument or as corrected by you in the space provided. If your name has changed, sign your current name and attach a copy of the marriage certificate, divorce decree, or other document supporting the change.

**YOUR NAME SHOULD READ THE SAME WAY THAT YOU USE FOR INCOME TAX FILING.**

**JOINT INTERESTS, LIFE ESTATES, AND USUFRUCTS:** All parties must execute for joint interests and for life estates or usufructs, including the remaindermen or naked owners.

**CORPORATIONS:** Title of the signatory party must be shown with signature attested. Attester must be identified by title and corporate seal affixed.

**SECOND PARTY:** If the instrument is signed by an agent, attorney-in-fact, guardian, or any party, other than the named interest owner, evidence of the rights vested in the signatory party must be furnished.

**PAYMENTS:** Upon receipt of the properly executed division order, we will authorize payment to you for your interest. Checks will be mailed in the last week of the month when the amount to be paid to you is more than \$100.00. We will issue checks for less than that amount at least once per year.

**CHANGE OF ADDRESS:** PLEASE NOTIFY US PROMPTLY OF ANY CHANGE IN YOUR MAILING ADDRESS. For your protection, this notice must be in your own signature or the signature of your appointed agent. Always include the last four digits of your social security number and your old address as well as the new address and zip code.

**CHANGE OF OWNERSHIP:** PLEASE NOTIFY US PROMPTLY OF ANY OWNERSHIP CHANGE.




