- 2. That the County's application be placed for funding under the STEP Fund.
- 3. That the application be for \$304,230.00 of grant funds to carry out water system improvements, project engineering, and program auministration.
- 4. That, should additional project funds be necessary, payment of these project costs shall also be the responsibility of the Deadwood Water Supply Corporation.
- 5. That the Board of Directors of the Deadwood Water Supply Corporation directs and designates the President as its Authorized Representative to act in all matters in connection with this application.
