SMALL TOWNS ENVIRONMENT PROGRAM (STEP) GRANT AGREEMENT

PANOLA COUNTY/DEADWOOD WATER SUPPLY CORPORATION

This is a contract between Panola County, Texas, a political subdivision of the State of Texas acting by its duly elected Commissioners Court, herein called County and Deadwood Water Supply Corporation, herein called the Corporation.

The purpose of this agreement is to set forth the terms between the parties. The County agrees to submit an application for a Texas Community Development Block Grant Program grant to the Texas Department of Agriculture (TDA) in the amount of \$304,230.00 to be used for water improvements as addressed in the County's Texas Community Development Block Grant Small Towns Environment Program (STEP) application.

Those terms are:

- 1. The County agrees to serve a fiscal agent for the grant, if awarded.
- 2. The Corporation shall bear any additional costs incidental to this project above grants funds.
- 3. The Corporation agrees to continue to operate the water system and shall maintain the services and improvements addressed in the County's TxCDBG application.
- 4. This contract is performable in its entirety in Panola County, Texas. The Corporation agrees that it will completely indemnify and hold harmless the County from any and all claims and from any and all financial obligations or claimed obligation relating to project.
