- a resolution stating who the new authorized signatory is (not required if this original resolution names only the title and not the name of the signatory), and
- a revised TxCDBG *Depository/ Authorized Signatories Designation Form (Form A202)*




The County Judge be authorized to execute contractual documents between the Texas Department of Agriculture and the County for the 2016 Texas Community Development Block Grant Program


