Section 3406 of the Internal Revenue Service Code requires that 28% Backup Withholding Tax be withheld if your correct taxpayer identification number (TIN) is not provided. You may also be subject to a \$50.00 penalty by the IRS under Section 6721 of the Internal Revenue Service Code for failing to provide us with your correct TIN.

The TIN for an individual is the Social Security Number (SSN).
