- Replace both lifting cables on one door, and check, lube and adjust the springs, rollers and side lock as needed..
- Replace a rusted side lock on one door, and check, lube and adjust the springs and rollers as needed.
- Level one door, and check, lube and adjust the springs, rollers, and side lock as needed.
- Check, lube and adjust the springs, rollers and side lock on two (2) other doors.

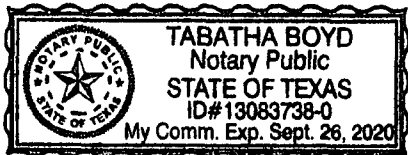
