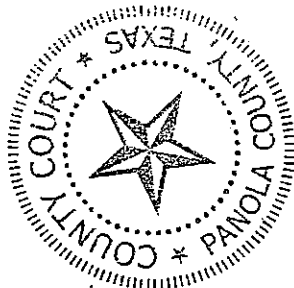
### OPENING PRAYER.

### OPEN MEETING:

1. To discuss and act upon payment of an Intergovernmental Transfer (IGT) to the State of Texas to support the continued provision of public indigent health care services to County residents through ETMC Carthage. An emergency and urgent public necessity and a need for immediate action exists and was unforeseeable because notice of the amount of the IGT required to be paid was not provided by the State to the County more than 72 hours prior to this meeting. Immediate action is needed to avoid an imminent threat to public indigent health because failure to approve the IGT at this meeting will prevent the County from complying with the IGT payment deadline and will result in a reduction of public indigent health service to county residents; and to approve payment of current Panola County IGT bill as prepared and submitted by the County Auditor.
