8 years ago VIP Technologies installed the SV8300 Phone System come May 31st we will no longer be able to get service from NEC due to the Software support ending come 1 Dec2018 will be end of life for this product. The NEC platform allows migration to the next generation system the SV93.

With this quote the Main Processor (CPU) and Voice Mail will be replaced plus all the licensee that are needed (\$36,423.00) programmed and Installed

This will give the Court House another 5years of Hardware and software coverage/support from NEC for these parts. At the need of the 5 years 2023 you can buy another software assurance program for 5 years 2028 giving you a total of 10 more years out of this system upgrade and system.

The Phones will not be covered if they go bad you would just replace them with the newer model phones which would come with a 5 year warranty on them.

This price is good for this month only and the Voice Mail replacement part discount will go away at the end of this month (March 30th 2018)

NEC end of year is March 31st 2018

NEC has given me 60days to pay this note if you would like to move forward with this I can order the system will need PO # for the amount of \$36423.00, Then payment will be due after installation.

In 2023 the software Warranty should be no more than 10k (more than likely less) for 5 more years.
