PRAYER: Commissioner John Gradberg gave the prayer.

OPEN MEETING:

1. CITIZEN COMMENTS:

Concerned citizens spoke to the Court about Isaiah 58 Farms potentially housing up to forty previously convicted persons in Panola County. Those responsible for Isaiah 58 Farms were present, and stated that they would like to have a community forum to address concerns in the near future. Judge Jones also assured those present that she has been in touch with the county's legal representatives and will address future issues as they arise.

Upon recommendation by those present from the Texas Forest Service, Judge Jones agreed to enact an emergency 7-day burn ban for Panola County.
