- 1.1 CRWW. CRWW expands the benefits of the Service to include automatic launching of prerecorded CRWW Notifications to Contacts of CRWW Licensee within the Calling Area specified in the CRWW Order who have added their name and geographic location to the CRWW Licensee database via the CRWW Licensee's community notification enrollment site. CRWW will notify ONLY those Contacts within the Calling Area that have CHOSEN to participate through the opt-in process. Notifications placed automatically via CRWW have no effect on the Message Units associated with the Service. CRWW is available only as an add-on feature for the Service. Accordingly, upon termination of the Agreement, access to CRWW will terminate and Provider shall terminate all individual CRWW Licensee accounts.
- 1.2 CRWW Term. The CRWW Initial Term shall begin on the Order Date and continue for the period set forth on the CRWW Order Form. Upon completion of the CRWW Initial Term, CRWW Licensee may renew the CRWW Order Form for successive renewal terms (each a "CRWW Renewal Term") as set forth on the CRWW Order Form, by providing any of the following to Provider renewal terms (each a "CRWW Renewal Term") as set forth on the CRWW Order Form, by providing any of the following to Provider prior to the end of the CRWW Initial Term or then-current CRWW Renewal Term: a signed CRWW Order Form for the CRWW Renewal Term (in electronic or hard copy format); a purchase order for payment for one additional year, or payment for one additional year.
- 1.3 CRWW Fees. Each CRWW Licensee shall pay Provider for the CRWW Service as set forth in the applicable CRWW Order Form. Invoices shall be sent to the CRWW Licensee at the address specified in the applicable CRWW Order Form. Pricing for the CRWW Service is separate and independent from the pricing for the Service.
- 1.4 CRWW Termination. The CRWW Service can be removed by CRWW Licensee by providing written notice prior to the commencement of any CRWW Renewal Term; provided however, CRWW Licensee shall pay all unpaid CRWW fees that would become due under the then-current term and no fees paid hereunder shall be refunded.

By signing below, CRWW Licensee agrees to pay Provider the fees set forth herein. CRWW Licensee agrees to comply with the terms and conditions set forth in the Agreement and this CRWW Order Form. This CRWW Order Form supersedes all prior agreements, written or oral, between CRWW Licensee and Provider relating to the subject matter of this CRWW Order Form. Except as otherwise provided, this CRWW Order Form may not be modified, changed, or discharged in whole or in part, except in a writing signed by Licensee and Provider.
