## PEST AGREEMENT

This agreement entered into this 10th day of Dec., 2019 by and between **Panola County**, hereinafter referred to as the “**Company**” and **Gecko Pest Control LLC**, hereinafter referred to as “**GPC**”.

That for and in consideration of the amount hereinafter set out, GPC hereby agrees with said Company to furnish pest services at the Company’s premises as described in Schedule I in accordance with the following:

### A. INTENT

1. These specifications shall cover and include the furnishing of all professional services, skilled services, labor, materials, tools, insurance, permits and fees, if any, necessary to accomplish the pest elimination hereinafter described for Company.
2. Rodent control equipment if needed will be quoted as necessary to be paid for by Company.

### B. SCOPE OF WORK

1. The pest services contemplated by these specifications shall be as described in Schedule II. Pest to be included: Roaches, Ants, Rats and Mice.

### C. SCHEDULE

1. GPC service representatives shall make additional service visits of emergency nature to achieve and maintain control at no additional cost.
2. All Services shall be rendered in such a manner as shall cause minimum interference with the Company's employees and other persons in and about the premises.
3. Services shall be provided without discrimination for any reason regarding sex, age, race, color, religious creed, national origin, ancestry or physical handicap.

### D. COMPANY COOPERATION

1. The Company shall extend all necessary cooperation to ensure effective pest elimination results
2. Whenever conditions conducive to the breeding or harborage of pests covered by this agreement are found to exist, such conditions are to be reported in writing by GPC to the Company, and the Company shall make all reasonable efforts to eliminate such conditions.

### E. INSURANCE

1. For the protection of the Company, GPC shall carry adequate limits of insurance including:
  - a. Public Liability
  - b. Property Damage
  - c. Workers Compensation
  - d. Provide Proof of Coverage

**RESPONSIBILITY**

1. It is understood that GPC alone is responsible for the employment, control and conduct of GPC employees and for damage to property or injury of such employee in the course of their employment or otherwise and to others through the acts or neglect of such employees or others.
2. GPC hereby expressly indemnifies and holds the Company harmless from any loss, expense or claim arising out of any such damage or injury.
3. In the performance of the work herein contemplated, GPC is an independent contractor with the authority and responsibility to control and direct the performance of the details of the work, the Company being interested only in the results obtained. But, the work contemplated herein shall be subject to inspection by the Company to ensure that the work performed meets with the Company's approval and is achieving the desired results.
4. All pesticides and equipment will be used in accordance with applicable city, state, and federal regulations. All pesticides will be EPA registered.
5. GPC will provide qualified personnel to perform said services. Personnel to be uniformed and to provide services in a professional manner. Pesticide application will be made by a Certified Applicator or under the direct supervision of a Certified Applicator.

**COST**

1. The cost of the services described herein shall be as described in Schedule IV.
2. GPC shall bill the Company monthly for services rendered during the month and the Company shall pay GPC within thirty (30) days of receipt of invoice.



**TERMS OF AGREEMENT**


1. The terms of this Agreement shall be for one year from date of first service and will renew on a month to month basis thereafter.
