AGREEMENT FOR INFORMATION TECHNOLOGY PRODUCTS & SERVICES

AMENDMENT No. 1

THIS Agreement Amendment No. 1 (this "Amendment") is made and entered into as of the 15th day of November 2021 (the "Amendment Effective Date"), by and between The County of Panola, Texas, ("County") and Avenu Government Records Services, LLC. ("Avenu"). The County and Avenu (each individually a "Party "and collectively "the Parties") agree as follows:

Whereas, the County of Panola, entered into an Information Technology Products & Services Agreement ("The Agreement") with Government Records Services, Inc. (a Xerox company), on September 1st, 2016;

WHEREAS the initial term of the Agreement was for five (5) years, through December 31, 2021;

WHEREAS Xerox divested some of its business (including Government Records Services, Inc.) to Conduent™ and change the name of the business to Conduent Government Records Services, Inc. in October of 2016;



WHEREAS on September 28, 2018, Avenu Holdings, LLC ("Avenu") acquired Conduent Government Records Services, Inc., including this Agreement with Panola County;

WHEREAS on October 30, 2018, Avenu filed a Certificate of Name Change with the Delaware Secretary of State and subsequently changed the name from Conduent Government Records Services, LLC., to Avenu Government Records Services, LLC.

NOW THEREFORE, the parties agree as follows:

1. This Amendment becomes effective as of January 1, 2022.
2. The parties agree to extend the term of the Agreement with this Amendment No. 1 as follows:
 - A. *Amend Section 2. TERM. The term of the Agreement is extended for a period of three (3) months, commencing on January 1, 2022, and ending on March 31, 2022, unless otherwise extended or terminated by the parties in accordance with the provisions of this Agreement ("Term"). Any future extension to the Agreement shall be subject to the termination provisions of this Agreement.*
3. Except as provided in this Amendment, all terms, and conditions of the original Agreement (as previously amended, if applicable) remain in full force and effect.

WHEREAS the initial term of the Agreement was for five (5) years, through December 31, 2021;

WHEREAS Xerox divested some of its business (including Government Records Services, Inc.) to Conduent™ and change the name of the business to Conduent Government Records Services, Inc. in October of 2016;



NOW THEREFORE, the parties agree as follows:
