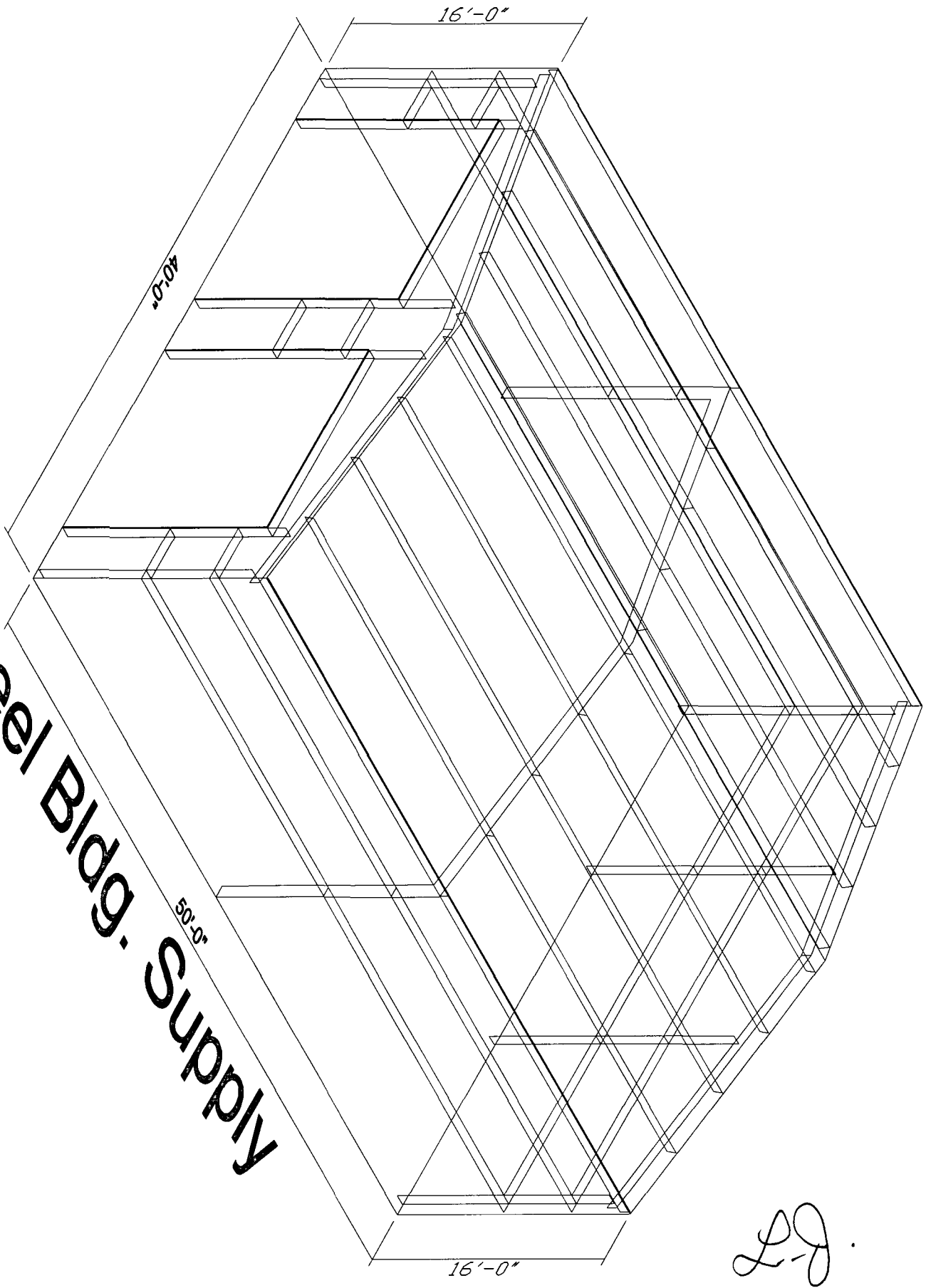

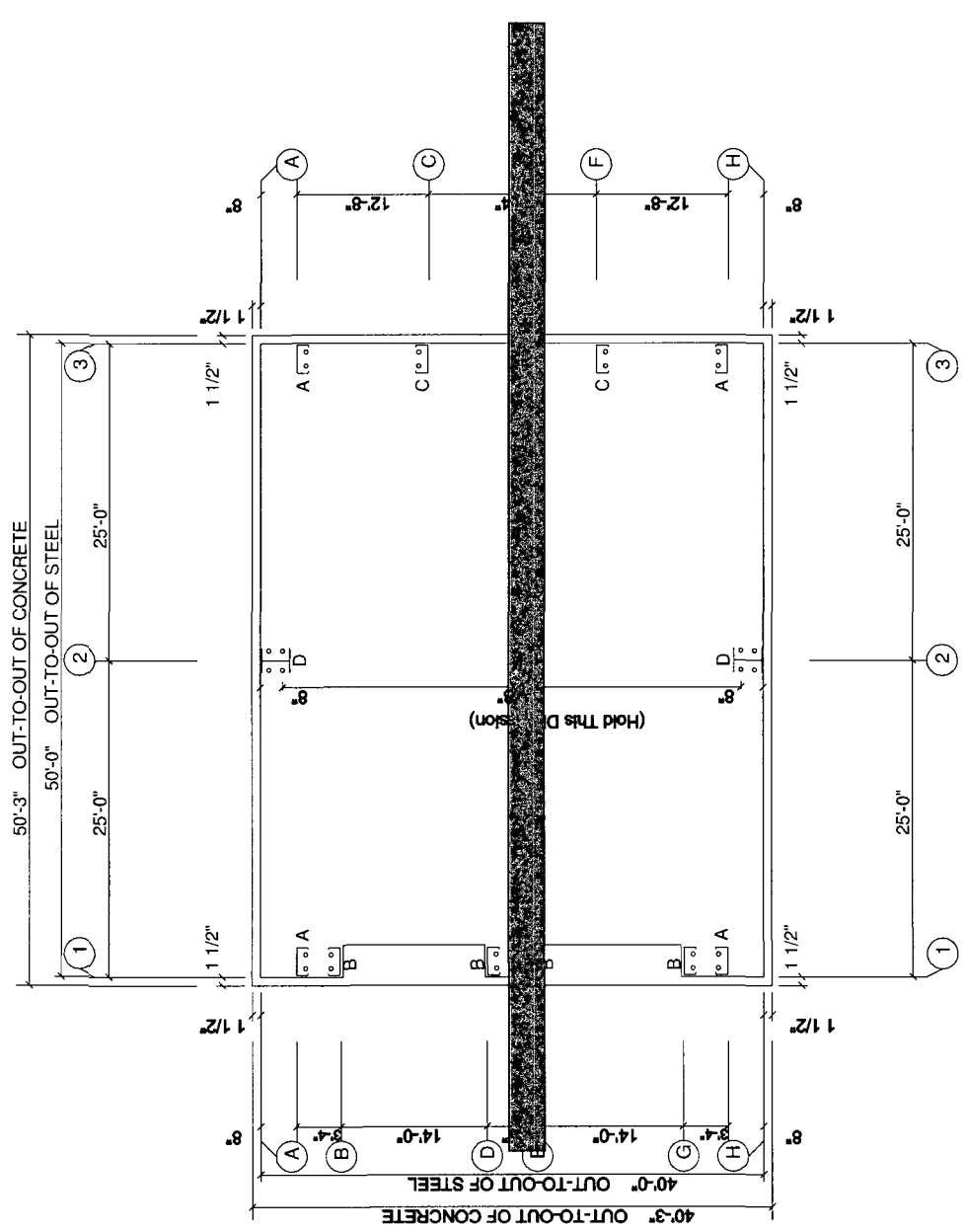

 NOTE: All Base Plates @ 100'-0" (U.N.)



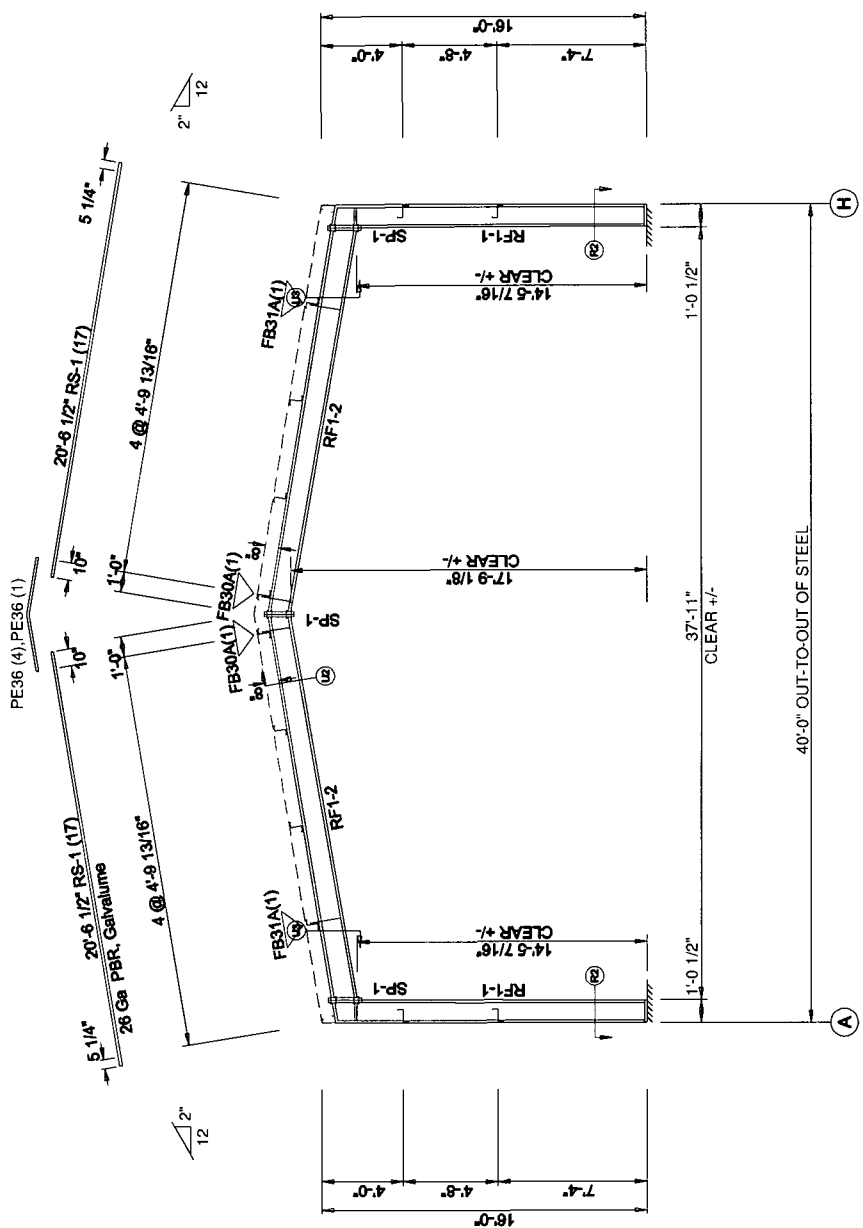

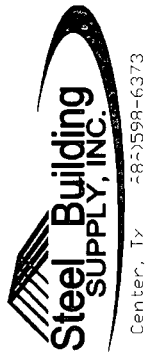

**RIGID FRAME ELEVATION: FRAME LINE 2**



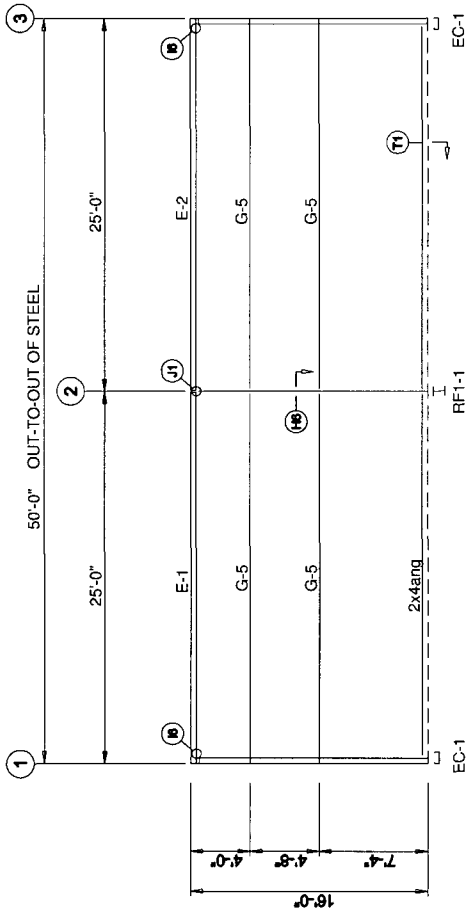

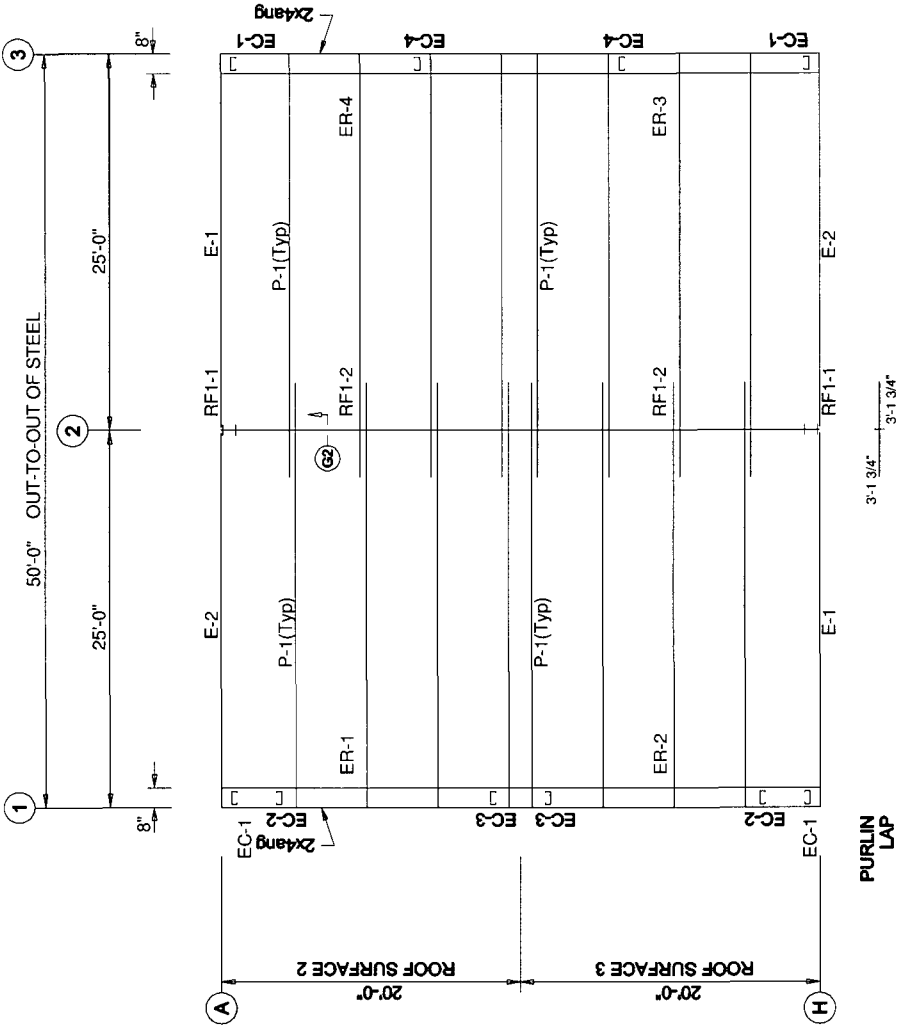
