GENERAL DESCRIPTION

Guardian Security Solutions plans to provide a camera system upgrade from GeoVision to Digital Watchdog for Panola County Courthouse for 52 existing GV IP cameras and consolidating from 2 existing NVRs into the newest NVR from 2019. We will also add 5 hard drives to have up to 30 days recording. With the implementation of Digital Watchdog Spectrum, an enterprise-level video management system (VMS), the customer can expect ease of use, speed, efficiency and unprecedented image quality. The Deputy Sheriff, Bailiff, IT Director, Maint Supv will be able to monitor applicable cameras using Digital Watchdog client software on their existing workstation or their mobile App for remote viewing. We will also replace the existing Control Center PC in the Courthouse Deputy Sheriff room to view all 52 cameras to remedy the sluggishness it is currently experiencing. We will not be changing anything to do with the existing Commissioner's Court Conference Rm stand-alone GV NVR since it is working and everyone is happy with its performance. Guardian does not provide a warranty for the existing 52 cameras nor the existing NVR's, Switches, UPS's, cabling since they are over several years old but we do provide a full 1-year warranty on the new products we install including Parts, Labor, and Travel.

Training will be provided to staff at the conclusion of the project. Repeat or refresher training is available at any time for an additional fee. Please help us deliver the best training possible by having all employees that need to be trained available for training during the installation timeframe.

Guardian Security believes this scope of work to be accurate based on industry standards and best practices. If unforeseen circumstances should dictate a change to this scope of work, a change order will be issued for approval at that time. Guardian Security is not responsible for the existing NVR + cameras operations after the software upgrade. It should be noted that in some rare cases a firmware update may be required for the NVR and any camera demonstrating compatibility issues and if that doesn't work then the NVR or camera must be replaced due to the incompatibility.
