

ORDER #2022-08


WHEREAS, the Local Government Code, Section 130.902, V.T.C.A. allows for the Commissioners' Court of a county to set aside from the general fund of the county an amount approved by the County Auditor for use as a change fund by any county or district official who collects public funds. Section 130.902 further states that said fund may be used only to make change in connection with collections that are due and payable to the county, the state, or another political subdivision of the state that are often made by the official; and


WHEREAS, Panola County Tax Assessor Collector Holly Gibbs has requested that the **Auto Registration Office** change fund of **FOUR HUNDRED -FIFTY AND NO/100 (\$450.00) DOLLARS** be increased by **TWO HUNDRED AND NO/100 (\$200.00) DOLLARS** bringing it to a total of **SIX HUNDRED -FIFTY AND NO/100 (\$650.00) DOLLARS** so that the Auto Registration Office can better make change in connection with collections that are payable to the County; and

WHEREAS, Jennifer Stacy, the County Auditor of Panola County, Texas, has recommended the change fund be increased from **FOUR HUNDRED-FIFTY AND NO/100 (\$450.00) DOLLARS** by **TWO HUNDRED AND NO/100 (\$200.00) DOLLARS** bringing the total change fund to **SIX HUNDRED-FIFTY AND NO/100 (\$650.00) DOLLARS** in the Panola County Auto Registrations Office.


NOW, THEREFORE, IT IS ORDERED, by the Commissioners' Court of Panola County, Texas, meeting in Open Session at a properly scheduled meeting of said Court, that an additional **TWO HUNDRED AND NO/100 (\$200.00) DOLLARS** be set aside from the general fund bringing the total change funds to **SIX HUNDRED-FIFTY AND NO/100 (\$650.00) DOLLARS** for the Panola County Auto Registration's Office.

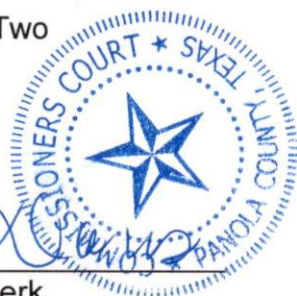




