The motion to amend the proposed budget carried by a vote of 3-0-1, with Commissioner David A. Cole abstaining. said RFQ being the Panola County, Texas Request for Qualifications for architectural and other professional services (including engineering services) necessary or desired for the County's Auxiliary Building Project, said project being located on certain real property in the City of Carthage, Panola County, Texas; and authorizing the County Judge to initiate contract negotiation with Flowers Association in order to attempt to negotiate and complete a contract at a fair and reasonable price as required by law.
