**PRAYER:** County Judge David L. Anderson gave the prayer.

#### **OPEN MEETING:**

#### 1. CITIZEN COMMENTS:

Clarissa Moon, Agrilife Extension Agent, announced an employee wellness program she has implemented. She invited all county employees to participate in a walking group to meet twice weekly for 15 minute walks.

Keri Vance, Executive Director of Panola County Chamber of Commerce, reported that Potlatch was a success, announced upcoming business openings, the Panola College Anniversary Celebration, and the upcoming Economic Development Workshop.

Andy Coats addressed the Court concerning the recent purchase of real property by the County.

#### 2. **COMMISSIONERS' REPORTS:**

David A. Cole, Commissioner Precinct #2 reported that the bridge on CR 224 should be completely repaired and open by the end of the month. The recent repairs were funded by a TxDOT grant.
