Dear Commissioners,

I am writing you today in reference to the cases from my private practice that are not yet finished.

Insomuch, I am asking the Court to allow me to finish those cases, both civil and criminal, that are not yet completed. Upon advice of counsel, this may be done pursuant to Attorney General's Opinions 540 and 497. This is accomplished by this Court waiving any conflict between me appearing before Judge Terry Bailey or Judge LeAnn Rafferty. As the judges are operating under the 2023 budget approved by this Court and Judge Anderson, I believe there will be no conflict of interest between myself, my clients, the Courts, or the County.

In my criminal cases, all clients have been extended offers by the Criminal District Attorney's office. If I were to withdraw from those cases, the County would pay both me and another attorney to plea out the already resolved cases. Approving me to finish could save the County approximately \$5,000.
