The Panola County Commissioners' Court offers no objection to the location on the right-of-way of your proposed **1 - 4", 1-6", & 1-8" water and gas lines** within the right-of-way of County Road #1881 as shown by accompanying drawings and notice except as noted below.

It is expressly understood that the County Commissioners' Court does not purpose hereby, to grant any right, claim, title or easement in or upon this county road. It is further understood that in the future should for any reason the county need to work, improve, relocate, widen, increase, add to, or in any manner change the structure of this right-of-way, any required relocation of said lines shall be at the sole expense of owner.

All work on the county right-of-way shall be performed in accordance with the county instructions. The installations shall not damage any part of the road and adequate provisions must be made to cause minimum inconvenience to traffic and adjacent owners. Special specifications for placing this line are as follows:

1. All lines are to be installed a minimum of 36 inches below the flow line of the adjacent drainage or barrow ditch.
2. All excavation within the right-of-way and not under surfacing shall be backfilled by tamping in 6 inch horizontal layers. All surplus material shall be removed from the right-of-way and the excavation finished flush with surrounding natural ground.
3. Lines crossing under surfaced roads and under surfacing cross roads within the right-of-way shall be placed by boring. Boring shall extend from crown line to crown line. Gravity from sewer lines under roadways shall be cast iron pipe.
4. All lines, where practicable, shall be located to cross roadbed at approximately right angles thereto. No lines are to be installed under or within 50 feet of either end of any bridge. No lines shall be placed in any culvert or within 10 feet of the closest point of same.

5. Parallel line will be installed as near the right-of-way lines as is possible and no parallel line will be installed in the roadbed or between the drainage ditch and the roadbed without special permission of the Panola County Commissioners' Court.
6. Operations along roadbeds shall be performed in such manner that all excavated material be kept off the pavement at all times, as well as all operating equipment and materials. No equipment or installation procedures will be used which will damage any road surface or structures. The cost of any repairs to road surface, roadbed, structures or other right-of-way features as a direct result of this installation will be borne by the owner of this line.
7. Barricades, warning signs, lights, and flag man(men) when necessary shall be provided by the contractor or owner. One-half (1/2) of the traveled portion of the road must be open at all times.

CR 1881 Pipeline Crossing

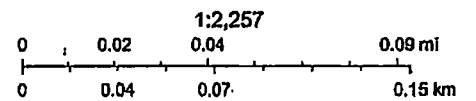

4.07 WORK PERIODS; OVERTIME AND COMPENSATORY TIME

The *Panola County* work week is from 12:01 a.m. on Saturday of each week to 12:00 Midnight of the succeeding Friday.

Overtime work is discouraged and must be approved by the employee's immediate supervisor prior to the performance of the work. Overtime is the hours worked in excess of 40 hours in a single work week. Authorized paid holidays will be included as hours worked. Sick time, vacation time or any other time not actually worked (except authorized paid holidays) will not be included when computing overtime. Overtime pay will be allowed only when authorized by an appropriate supervisor or when absolutely necessary in an emergency. For nonexempt employees, if hours actually worked exceed 40 hours in a single workweek, authorized compensatory time will be allowed to accrue in lieu of overtime payments. Compensatory time is earned on the basis of 1 ½ hours of compensatory time for each hour worked in excess of 40 hours in a single work week. This compensatory time should be used as soon as practical and should be used before vacation time is requested. The County may require an employee to use accrued compensatory time at any time.

Certain positions in law enforcement work in swing shifts over a 14 day work period. Compensatory time for the law enforcement positions is earned on the basis of 1 ½ hours of compensatory time for each hour worked in excess of 86 hours in a 14 day work period.

Dispatchers are civilian employees as defined by the federal government. For these employees the workweek is 7 days with hours worked being 40. A dispatcher will be paid bi-weekly for hours worked up to 80 hours. Hours in excess of 40 hours worked in a workweek, will be earned as compensatory time (1 ½ times the regular rate). If a dispatcher works under 40 hours one week during a bi-weekly pay period, but over 40 in the other week of the bi-weekly pay period, compensatory time will be used to pay the dispatcher a bi-weekly check for 80 hours worked.

Certain employees are designated as "exempt employees" pursuant to Fair Labor Standards Act regulation. Exempt employees do not earn overtime or compensatory time. They are expected, at times, to work extra hours. Your supervisor will let you know if you are such an exempt employee. Depending upon the needs of the Department, a department head may allow an exempt employee to arrive late or to take off early in recognition of extra hours worked, but this is at the discretion of the department head.

Improper deductions from the pay of exempt employees is prohibited. If an exempt employee believes that an improper deduction from his/her salary has been made, a complaint should be made to the County Treasurer. The County Treasurer will investigate the complaint. Upon a finding by the County Treasurer that an improper deduction was made, the exempt employee will be reimbursed in the amount of the improper deduction and the County will make a good faith effort not to make future improper deductions.

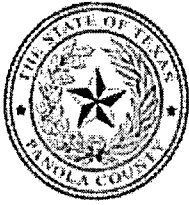

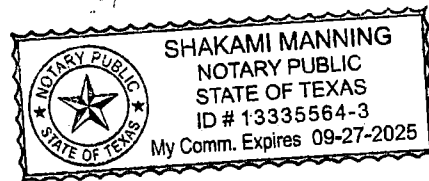


