




## Panola Co Annex in Carthage TX (316 W Sabine Str)


## Add 3 Doors to Access Control

1. Front Door = Aluminum Retail Door with side lites (example) still to be installed, sheet rock and wooden stud wall, under counter push button, slim reader, 1/2 rim strike, in-line power pack



2. Side Door = hollow metal door, sheet rock and wooden stud wall with brick outside, slimline mag, release timer, armature plate holder, no touch piezo, single gang reader





3. Back Parking Door = hollow metal door, sheet rock and wooden stud wall with brick outside, slimline mag, release timer, armature plate holder, no touch piezo, single gang reader
