Gentlemen:

I am pleased to confirm my understanding of the terms and objectives of my engagement and the nature of the limitations of the services I will provide. The engagement between you and my firm will be governed by the terms of this Agreement.

My Responsibilities

The objectives of my engagement are to provide the following services:

- I will perform a physical inventory count of all capital assets of the Panola County Road and Bridge Department and the Panola County Sheriff's Department.
- I will prepare the capital asset listing and depreciation schedule of all capital assets of Panola County, Texas as of December 31, 2023. My procedures will include a review of the minutes of all Commissioners Court minutes for the year, a review of the general ledger, accounting records and insurance policies, and inquiries of responsible officials to identify current year additions and disposals for the year ended December 31, 2022.
- I will prepare the footnote disclosures related to the capital assets of Panola County and the supplementary schedules applicable to the capital assets of Panola County in a manner so that it can be submitted to the County's independent auditor for inclusion in the County's comprehensive annual financial report (CAFR).
- I will correspond as needed with the County's independent auditor to respond to any inquiries and/or questions related to my work performed and the schedules and disclosures I prepared.

The above information will be prepared in a manner to meet the requirements of the Governmental Accounting Standards Board. The actual documents, summaries and narratives associated with the work will be submitted to the County Auditor, or at her request, directly to the independent auditor of the County.

My engagement to provide the accounting services outlined above is dependent upon the timeliness, accuracy and completeness of the information and representations that I receive from you. Therefore, providing me with inaccurate or incomplete information or representations may result in incomplete or inaccurate information reported by me. If information changes during the course of the engagement, you must provide my office with the updated information and representations on a timely basis, as the change in information may affect my reports. I will not audit or otherwise verify the data you submit to me, although I may ask you to clarify certain information.

These services cannot be relied on to disclose errors, fraud, or illegal acts. However, I will inform you of any material errors and of any evidence or information that comes to my attention during the performance of my services regarding illegal acts that may have occurred, unless they are clearly inconsequential. I have no responsibility to identify and communicate deficiencies in your internal control as part of this engagement.

This engagement is limited to the professional services outlined above.

Your Responsibilities

You are responsible for assuming all management responsibilities and for overseeing the non-attest services I will provide by designating an individual, Jennifer Stacy, County Auditor, who possesses suitable skill, knowledge, and experience. In addition, you are responsible for evaluating the adequacy and results of the services performed and accepting responsibility for the results of such services.

As a condition of my performing the services described above, you agree to:

- Evaluate the adequacy and results of the services performed;
- Make all management decisions and perform all management functions;
- Accept responsibility for the results of the services;
- Establish and maintain internal controls as well as monitoring ongoing activities.

You are responsible for the presentation of the capital asset listing and depreciation schedule of all capital assets, and for the related footnote disclosures and supplementary schedules.

Engagement Administration, Fees and Other

I, Rachael Payne, am responsible for the engagement.

I estimate that my fees for these services will be approximately \$5,500. This fee estimate is based on anticipated cooperation from your personnel and the assumption that unexpected circumstances will not be encountered during the engagement. If significant additional time is necessary, I will discuss it with you and arrive at a new fee estimate before I incur the additional costs.


