As such, his son Taylor Harris is ineligible to serve on the Panola County Board of Directors per Texas Tax Code Sec. 6.412(a)(3) "(a)An individual is ineligible to serve on an appraisal review board if the individual: (3) is related within the third degree by consanguinity or within the second degree by affinity, as determined under Chapter 573, Government Code, to a member of the appraisal district's board of directors." Election of Taylor Harris would make Mark Harris ineligible to serve on the ARB. Thank you for your attention in this matter.
