Below is the TIPS pricing for your Book Preservation Project for 2025. There are 23 Book involved, but I assume you will have those 12 pages in the other Comm Court A that had a date of 1949 added to another volume. We would of course add a divider sheet and notate the lettering you want on that divider to identify those 12 pages. That makes it 22 Books for Preservation.

We would come down and security scan each book before packing them up and leave you the raw images so you would have access while we have the books.

The data you get back would be in crisp PDF by digital Book/Page. Comm Court G to T would have OCA added to the images so that you can word search those. Of course, the others are handwritten, and OCA would be of no value. All photostat Book images will be turned into nice black on white digital images so they would be easily readable.

The proposal includes delivering digital PDFs by Book/Page. We would have to charge if your Comm Court Software provider wanted them in a different way.
