OPEN MEETING:

1. CITIZEN COMMENTS:

Keri Perot-Vance, Executive Director of the Panola County Chamber of Commerce reported on recent and upcoming events in the County. Mrs. Vance congratulated Panola County Fire Marshal/Emergency Services Coordinator Bryan Murff for being recognized as Panola County Citizen of the Year at the recent Panola County Chamber of Commerce Banquet.

Mr. Keith Coleman reported that he has noticed a lot of trash on the State Highways in his area of the County. Judge McLane responded that the County Roads should be cleaned up soon, and Sheriff Cutter Clinton also responded with an explanation of the laws that address the circumstances under which a SWEAT team may work outdoors.

Mr. Gary Kelley addressed the Court on the topic of the 2026 Budget and possible tax increases. Judge McLane and the Court responded with an explanation of the budget process with an emphasis on the services in which a county is required by statute to provide funding, and explained that the decision to increase taxes is taken seriously by the Court. Mr. Chad Maines also addressed the Court on the topic of the 2025 tax increase, asking the County to give him a break. County Auditor Jennifer Stacy responded, citing the tax rates over the past 12-15 years in terms of cents on the dollar, noting the cyclical nature of property taxes. Commissioner Dale
