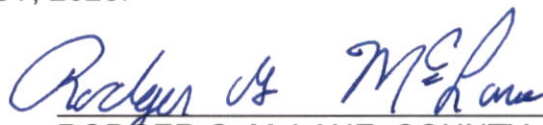


LEGAL NOTICE
