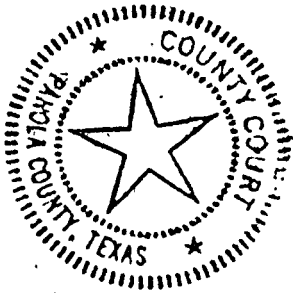

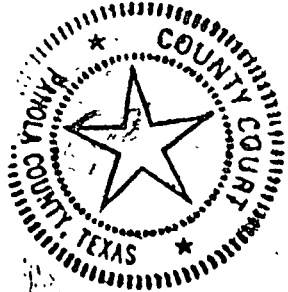

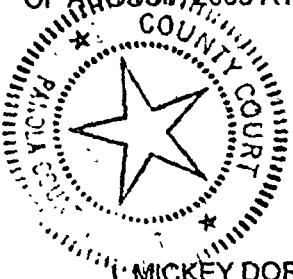

- SI. After some discussion with Bobby Sides of the Texas Forest Service there was no action to adopt Order #2005-10 concerning the prohibition of outdoor burning.

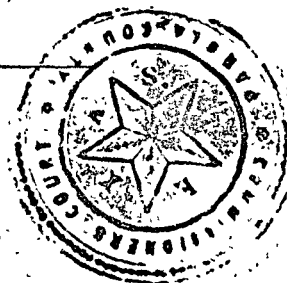
