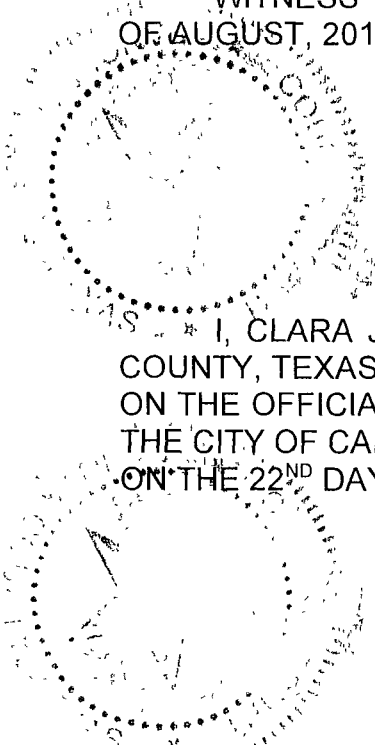

OPENING PRAYER

The prayer was given by Commissioner Ronnie LaGrone.

OPEN MEETING:


1. Judge Anderson moved that the property tax rate be increased by the adoption of a tax rate of .4994, which is effectively a 2.5 percent increase in the tax rate. Commissioner Ronnie LaGrone seconded the motion. This motion included to adopt Order #2012-14 setting the 2013 Tax Rate and Tax/Levy, and authorized the Tax Assessor-Collector to prepare tax statements with approved tax rate. (Local Government Code, Section 111.010). The motion passed by a vote of 4-1. Commissioner John Gradberg voted no.

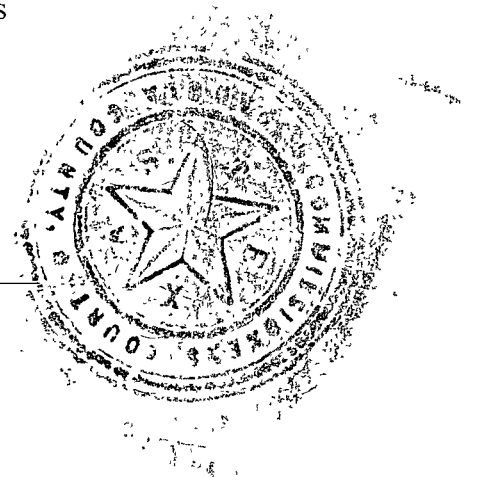
The meeting was then adjourned.

TOTAL	.4994


The above rates will appear on the tax statement as follows:



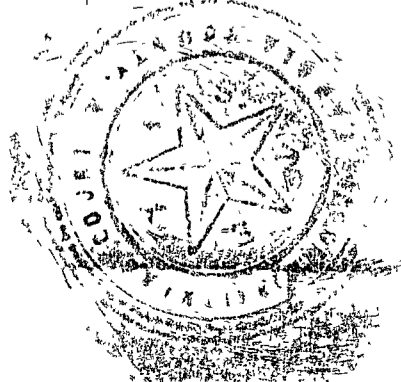
