Please accept this letter as a formal request to discuss a necessary price adjustment regarding our current culvert supply contract.

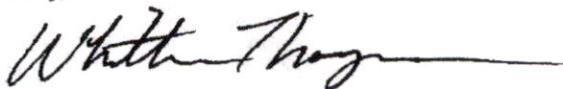
